#### **EDI CONNECT TERMS AND CONDITIONS**

By Your execution of a SOW with Blue Yonder Inc. (a Delaware corporation), or any its affiliates ("Blue Yonder") in relation to Your access to the Site, or by Your continued access to this Site and/or use of the applications or materials available on this Site, You agree to be bound by the terms of this Agreement, which shall govern Blue Yonder's provision of Services to You.   - ii. not signed the SOW but are accessing this Site and/or using the applications or materials available on this Site ("Visitor"), mean these Blue Yonder EDI Connect Terms and Conditions, as updated from time to time, together with the Blue Yonder's Services Terms and Conditions (accessible at <a href="https://blueyonder.com/legal/services-terms-and-conditions">https://blueyonder.com/legal/services-terms-and-conditions</a>).
- b.
